MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on October 27, 2009, the County Executive submitted to the Council President and Clerk of Council three letters nominating Ms. Candace Campbell Jackson, Ms. Anne Connell-Freund, and Mr. Dan Bell to the Children Services Board of Trustees; and






Dear Mr. Kostandaras and Ms. Greer:
