SUMMARY: A Motion of Council specifying the starting time for the Council meeting; and thereby rescinding M-065-2010 which was lacking a specific start time.

A MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 3.04 of the Charter of the County of Summit provides for County Council to determine its own rules and order of business; and

Whereas, Section 4.02 of the Rules of County Council states that no later than December 31 of each year, Council shall establish a schedule of the dates, times, and locations of all Regular Council meetings and meetings of Committees of Council for the following calendar year, including the Organizational Meeting required to be held pursuant to Section 3.04 of the Charter; and

Whereas, Section 3 of M-065-2010 did not establish a specific start time for Council meetings; and

Whereas, such schedule shall be widely disseminated by the Clerk;


