MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on October 7, 2013, the County Executive submitted to the Council President and Clerk of Council five letters nominating Mr. Russ Pry (with alternate Erin Gurm), Mr. Alan Brubaker (with alternates Larry Fulton and Joe Paradise) and Ms. Connie Krauss to the AMATS Policy Committee and Mayor Bill Gony and Mr. Dennis Tubbs to the AMATS Policy Committee and the Technical Advisory Committee.

- (4) The reappointment of Mayor Bill Gony to the AMATS Policy Committee and Technical Advisory Committee with a term beginning 1/1/14, and ending 12/31/14, to serve without compensation, is hereby confirmed.

- (5) The reappointment of Mr. Dennis Tubbs to the AMATS Policy Committee and Technical Advisory Committee with a term beginning 1/1/14, and ending 12/31/14, to serve without compensation, is hereby confirmed.
