**MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT**

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on January 23, 2017, the County Executive submitted to the Council President and Clerk of Council four letters nominating the appointments of Mr. Jon Oldham, Mr. John Schmidt (with David Hamilton as alternate), Mr. Scott Feeney (as an alternate for Sandra Kurt) and Ms. Donna Nicholas (with Chris Csonka as alternate) (replacing Dale Soltis) to the Criminal Justice Advisory Board; and

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Clerk of Council to prepare a Motion of Council for consideration at the next Regular Council meeting;

- (4) The appointment of Ms. Donna Nicholas (with Chris Csonka as alternate) (replacing Dale Soltis) to the Criminal Justice Advisory Board with a term beginning at the passage of this motion to 6/12/17, to serve without compensation, is hereby confirmed.


