A Resolution appropriating \$2,698,800.00, for the Energy Efficiency Conservation Block Grant ("EECBG"), from the U. S. Department of Energy, made available through the American Recovery and Reinvestment Act of 2009 ("ARRA") for a grant period ending 12/31/10, for the Executive's Department of Community and Economic Development, and declaring an emergency.
