7 **An amended Resolution, pursuant to Section 169.04(i) of the Codified Ordinances of the**
8 **County of Summit, approving and adopting the Report on Staffing for calendar year 2010,**
9 **and amending Exhibit A, for the Executive, and declaring an emergency.**

11 WHEREAS, Section 169.04(i) of the Codified Ordinances of the County of Summit
12 requires the County Executive to submit annually a report on staffing which sets forth the
13 number of full-time, part-time and seasonal positions within each job classification, that an
14 office, department, agency board or commission may employ during the following calendar year;

17 WHEREAS, the Report on Staffing submitted by the Executive must be adopted by this
18 Council no later than December 31st of each year; and

20 WHEREAS, the County Executive has submitted to this Council a Report on Staffing for
21 calendar year 2010; and

23 WHEREAS, it is necessary and in the best interest of the County of Summit to adopt the
24 Report on Staffing for calendar year 2010.

26 NOW, THEREFORE BE IT RESOLVED, by the Council of the County of Summit, State
27 of Ohio, that:

31 The Report on Staffing for calendar year 2010, which is attached hereto as amended
32 Exhibit A and incorporated herein by reference is hereby approved and adopted by this Council.

36 This Resolution is hereby declared to be an emergency in the interest of the health, safety
37 and welfare of the citizens of the County of Summit and for the further reason that it is necessary to
38 immediately approve and adopt the Report on Staffing prior to the deadline established by the
39 Codified Ordinances of the County of Summit.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
44 immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be
45 in force at the earliest time provided by law.
