7 **A Resolution appropriating carryover funds in the amount of \$133,000.00 for the Youth**
8 **Employment for Success (“YES”) Program, for the period 1/1/10 through 6/30/10, from**
9 **Department of Job and Family Services’ State Fiscal Year 2009 American Recovery and**
10 **Investment Act (“ARRA”) of Workforce Investment Act (“WIA”) Grants, with no local**
11 **cash match requirement, for the Executive’s Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Youth Employment for Success (“YES”) Program which provides job
15 readiness training, paid work experience, mentoring and guidance services for school youths
16 ages 16 -18 is funded by the State Fiscal Year 2009 American Recovery and Investment Act
17 (“ARRA”) Workforce Investment Act (“WIA”) grants, with no local cash match requirement;

20 WHEREAS, this Council previously adopted Resolution 2009-213, which authorized the
21 County Executive to execute, subject to the approval of the Board of Control, professional
22 service contracts for State Fiscal Year 2009 with certain providers for educational and
23 employment services for youth summer programs, for the period 5/1/09 through 9/30/09, and a
24 year-round program for the period 7/1/09 to 6/30/10, in a total amount not to exceed
25 \$1,005,980.00; and

27 WHEREAS, the carryover balance of these funds requires appropriations for operations
28 in the second half of the YES grant program year, for the period 1/1/10 through 6/30/10; and

30 WHEREAS, this Council has determined by reviewing all pertinent information that the
31 appropriation of the aforementioned grant funds is necessary and in the best interest of the
32 County of Summit;

SECTION 2
