A Resolution appropriating \$53,819.00 in federal funds, from the Ohio Department of Job and Family Services (“ODJFS”) for the Workforce Investment Act (“WIA”) Disability Program Navigator (“DPN”) Initiative Allocation, for the period 8/1/09 through 6/30/10, for the Executive’s Department of Job and Family Services, and declaring an emergency.

WHEREAS, ODJFS has awarded State Fiscal Year 2010 WIA DPN funds to the County of Summit, in a total amount of \$59,652.00, for the period 7/1/09 through 6/30/10; and

WHEREAS, \$5,833.00 of the WIA DPN funds were awarded earlier for July 2009 and appropriated in Resolution 2009-312; and

WHEREAS, the balance of grant funds in the amount of \$53,819.00 have now been distributed by ODJFS for the balance of the period from 8/1/09 through 6/30/10; and

WHEREAS, the award helps to fund a program which supports persons with disabilities in seeking employment by facilitating universal access to the One-Stop DPN service delivery system provided at the Job Center by Goodwill Industries, the County’s contracted provider for adult and dislocated services; and

WHEREAS, this Council has determined by reviewing all pertinent information that the appropriation of the aforementioned grant funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:


SECTION 5
