7 **A Resolution appropriating Workforce Investment Act (“WIA”) grant funds from the**
8 **Ohio Department of Job and Family Services (“ODJFS”), received as a result of the**
9 **American Recovery and Reinvestment Act of 2009 (“ARRA”) in the amount of \$25,000.00,**
10 **through 12/31/09, for the Executive’s Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, pursuant to Resolution No. 2009-088, the County Executive was authorized
14 to execute any documents necessary to accept additional federal funds received as a result of the
15 ARRA which was signed into law by President Obama on 2/27/09; and,

17 WHEREAS, ODJFS has allocated ARRA WIA funds in the amount of \$25,000.00,
18 which will be used for a program entitled “Project HIRE” for the state fiscal period of 9/1/09
19 through 6/30/10; and

21 WHEREAS, the purpose of Project HIRE is to assist adult dislocated workers in
22 obtaining employment through job search and/or training through the Ohio Learning Accounts
23 (“OLA”); and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is
26 necessary and in the best interest of the County of Summit to appropriate the aforementioned
27 ARRA WIA funds in the amount of \$25,000.00 received from ODJFS;
