7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award by the United States Department of Justice, Bureau of Justice Assistance,**  
9 **State Criminal Alien Assistance Program (“SCAAP”) grant of \$29,534.00, for Fiscal Year**  
10 **2009, with no local cash match requirement, for the Executive’s Department of Law –**  
11 **Public Safety Division/Justice Affairs, and declaring an emergency.**

13 WHEREAS, through the SCAAP passed by Congress, the Office of Justice Affairs in the  
14 U.S. Department of Justice annually grants funding to the jurisdictions for legitimate  
15 incarceration costs incurred as a direct result of the Federal Government’s failure to secure the  
16 border; and

17  
18 WHEREAS, the County of Summit has received grant funding and which may only be  
19 used for correctional purposes such as certain construction, certain training and/or education for  
20 offenders, and/or specialized training or wages for corrections officers; and

22 WHEREAS, the Bureau of Justice has awarded the County a Fiscal Year 2009 State  
23 Criminal Alien Assistance Program grant, in the amount of \$29,534.00, with no local cash match  
24 requirement; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
27 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
28 any documents necessary to accept the award of the aforementioned grant from the Department  
29 of Justice;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,  
32 State of Ohio, that:

34 SECTION 1

36 The County Executive is hereby authorized to execute any documents necessary to accept  
37 the Fiscal Year 2009 SCAAP award from the U.S. Department of Justice, Bureau of Justice  
38 Assistance, in the amount of \$29,534.00, with no local cash match requirement.

40 SECTION 2

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further reason of immediately  
44 accepting the Fiscal Year 2009 SCAAP grant fund award.

46 SECTION 3

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.


