## **SECTION 2**

2-3-4-5-6-7-8-9

The County Executive is hereby authorized to execute the Cooperative Agreement with the OWDA substantially in the form as set forth in the "Cooperative Agreement for Construction, Maintenance and Operation of State Water Project or Wastewater Project," attached hereto as Exhibit A (the "Cooperative Agreement"), for a 20-year loan in an amount not to exceed \$400,000.00 to fund construction of the Project. It is estimated that the total cost of the equipment and installation will not exceed \$400,000.00. The interest rate for the 20-year loan shall not exceed 7% per year. The Cooperative Agreement is approved with changes therein not inconsistent with this Resolution and not substantially adverse to the County which shall be approved by the County Executive; provided that the approval of these changes by the County Executive and the character of such changes as not being substantially adverse to the County shall be evidenced conclusively by the execution of the Cooperative Agreement.

## **SECTION 3**

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason that it will allow the County to immediately obtain funds to pay for a needed improvement.

## **SECTION 4**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 5**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
