A Resolution authorizing the County Executive to execute any documents necessary to accept an award in the amount of \$80,533.10 for a High Visibility Enforcement Overtime (“HVEO”) grant, with no local cash match requirement, from the Ohio Department of Public Safety, for the period 10/1/09 to 9/30/10, Grant #HVEO-2010-77-00-00-00317-00, and appropriating the grant funds for the period 10/1/09 through 12/31/09, for the Sheriff, and declaring an emergency.

WHEREAS, the Ohio Department of Public Safety, through the Ohio Traffic Safety Office (“OTSO”), offers funding for an HVEO grant program in the County of Summit; and

WHEREAS, the County Sheriff has been awarded \$80,533.10 with no local cash match requirement, from the Ohio Department of Public Safety for an HVEO grant to work overtime to conduct high visibility enforcement, public awareness, and education in the County of Summit; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the County Executive to execute any documents necessary to accept the aforementioned grant, and the appropriations of the aforementioned grant funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept an HVEO grant award from the Ohio Department of Public Safety, in the amount of \$80,533.10, with no local cash match requirement, for the period 10/1/09 through 9/30/10.

Grant funds are hereby appropriated for the period 10/1/09 through 9/30/10 as follows:


SECTION 6
