A Resolution authorizing the County Executive to execute any documents necessary to accept from the State of Ohio Attorney General's Office the Fiscal Year 2009-2010 Victims of Crime Act ("VOCA") grant in the amount of \$66,959.00 with a 25% local cash match requirement, and the Fiscal Year 2009-2010 State Victims Assistance Act ("SVAA") grant in the amount of \$3,470.00, and appropriating funds in the amount of \$25,500.00 for the period 10/1/09 through 12/31/09, for the Prosecutor, and declaring an emergency.

WHEREAS, the County of Summit Prosecutor's Office has been an ongoing recipient of VOCA and SVAA grants which help to support two full-time victim advocates; and

WHEREAS, the required VOCA 25% local cash match requirement has been budgeted in the Prosecutor's General Fund; and

WHEREAS, the VOCA and SVAA grants are funded on a federal fiscal year from 10/1/09 through 9/30/10, it is necessary to appropriate part of the VOCA grant and match funds for the balance of the 2009 calendar year in the amount of \$25,500.00; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the County Executive to execute any documents necessary to accept the aforementioned grants and that the appropriations of the aforementioned VOCA grant funds are necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the Fiscal Year 2009-2010 VOCA/SVAA award to the County of Summit Prosecutor's Office, providing \$66,959.00 of VOCA grant funds and requiring \$22,320.00 in local cash match funds, and also providing \$3,470.00 of SVAA grant funds for a combined total of \$92,749.00.

SECTION 2

SECTION 6
