A Resolution authorizing the County Executive to execute of any documents necessary to accept an award of American Recovery and Reinvestment Act ("ARRA") federal grant funds from the Ohio Office of Criminal Justice, in the amount of \$60,233.44, along with a 25% in-kind match requirement of \$20,085.15, for the period 7/31/09 through 7/31/10, for the Violence Against Women Act ("VAWA") Grant, and appropriating \$28,600.00 for the period 10/1/09 through 12/31/09, for the County of Summit Prosecutor, and declaring an emergency

WHEREAS, the County of Summit Prosecutor has been awarded an ARRA federal grant from the Ohio Office of Criminal Justice for the VAWA program, which assists female victims of violent crimes and educates grand jury members on issues of domestic violence and sexual assault; and

WHEREAS, the 25% in-kind match can be met with existing appropriations of salary and benefits within the Prosecutor's General Fund; and

WHEREAS, this Council has determined by reviewing all pertinent information that the acceptance of the aforementioned grant, and the appropriations of the aforementioned grant funding, are necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the VAWA grant with an in-kind match requirement, for the period 7/31/09 through 7/31/10.
