A Resolution authorizing the County Executive to enter into agreements for the acquisition of rights-of-way ("ROW") for the improvement of the Hazel Street Bridge over the Little Cuyahoga River, located in the City of Akron, Council District 2, at a cost not to exceed \$9,775.00, for the Engineer, and declaring an emergency.

WHEREAS, by Resolution No. 2008-235, this Council authorized agreements with the State of Ohio, Department of Transportation ("ODOT"), for the improvement of the Hazel Street Bridge over the Little Cuyahoga River, bridge number AKR-261-1169 located in the City of Akron (said improvement being referenced herein as the "Project"); and, also known by ODOT Project ID number ("PID") 22079, and

WHEREAS, ROW are needed for the Project; and

WHEREAS, ROW acquisition is considered a local cost which must be borne in whole by the local public agency performing a project, in this case being the County of Summit; and

WHEREAS, acquisition of the subject ROW will promote proceeding with the Project to bid; and

WHEREAS, this Council has determined by reviewing all pertinent information that the acceptance and approval of the aforementioned ROW acquisitions are necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## SECTION 1

In return for certain warranty deeds, a channel drainage easement, a utility easement and temporary highway ROW easements needed for the improvement of the Hazel Street Bridge over the Little Cuyahoga River, located in the City of Akron, Council District 2, ODOT PID 22079, the Executive is hereby authorized to execute agreements of purchase of said ROW, under which the owners of said ROW will be paid amounts not to exceed \$9,775.00, said owners and their respective payments (the negotiated value of their warranty deeds, channel easements, utility easement and temporary highway ROW) being as follows:
