A Resolution authorizing the County Executive to enter into a three-year policing agreement with the City of Green, Council District 8, to provide 17 Sheriff's Deputies, for the period January 1, 2009 through June 30, 2009, and 16 Sheriff's Deputies for the period July 1, 2009 through December 31, 2011, and one Direct Indictment Officer at 20 hours per week for the period January 1, 2009 through December 31, 2011, in the amount of \$1,644,984.70 for the first year, \$1,743,472.47 for the second year, and \$1,815,041.87 for the third year, in a total amount not to exceed \$5,203,499.04 during the three-year term of the agreement, for the Sheriff, and declaring an emergency.

WHEREAS, the Executive entered into a policing contract with the City of Green which terminated on December 31, 2008; and

WHEREAS, the City of Green hereby requests that the Executive enter into a new agreement to provide 17 Sheriff's Deputies for the period January 1, 2009, through June 30, 2009, and 16 Sheriff's Deputies for the period July 1, 2009 through December 31, 2011 and one Direct Indictment Officer at 20 hours per week for the period January 1, 2009 through December 31, 2011; and

WHEREAS, the City of Green has agreed to pay the County \$1,644,984.70 for the first year, \$1,743,472.47 for the second year and \$1,815,041.87 for the third year, for a total amount of \$5,203,499.04 during the three-year term of agreement; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the Executive to execute the aforementioned agreement is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## SECTION 1

The County Executive is hereby authorized to enter into a three-year policing agreement with the City of Green, Council District 8, to provide 17 Sheriff's Deputies for the period January 1, 2009 through June 30, 2009, and 16 Sheriff's Deputies for the period July 1, 2009 through December 31, 2011, and one Direct Indictment Officer at 20 hours per week for the period January 1, 2009 through December 31, 2011, in the amount of \$1,644,984.70 for the first year, \$1,743,472.47 for the second year, and \$1,815,041.87 for the third year, for a total amount of \$5,203,499.04 during the three-year term of the agreement.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of providing necessary policing for the City of Green.
