A Resolution appropriating \$4,477.07 in federal grant funds received from the U. S. Department of Justice for the Gang Resistance Education and Training ("G.R.E.A.T.") Program, for fiscal year 2009, for the Prosecutor, and declaring an emergency.

WHEREAS, the G.R.E.A.T Program received federal funding in 2007 which the County Executive was authorized to accept by Resolution No. 2007-467 and appropriated for 2008 by Resolution No. 2008-015; and

WHEREAS, all funds have been received from the U.S. Department of Justice for the GREAT Grant; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned funds in the amount of \$4,477.07;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:


SECTION 5


