WHEREAS, this Council has determined by reviewing all pertinent information that certifying the aforementioned charges to the Fiscal Officer is necessary and in the best interest of County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The delinquent sewage treatment accounts and delinquent plant operation and pump station accounts listed in the column titled "Sewer" and attached hereto as "Exhibit A" are hereby certified to the Fiscal Officer to be placed on the tax list and duplicate for collection as other taxes are collected.

SECTION 2

The Clerk of Council shall deliver a copy of this Resolution to the Fiscal Officer who shall record the delinquent sewer service charges for collection pursuant to state law.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately ensure the certification of charges to the Fiscal Officer.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
