An amended Resolution authorizing the Executive to execute a contract with Oriana House, Inc. for the operation of a community corrections program for State Fiscal Year 2010, the period July 1, 2009 through June 30, 2010, in the amount of ~~\$813,357.00~~ \$813,361.00, which is funded by a portion of the State of Ohio Department of Rehabilitation through the Community Corrections Act, 407 Grant and 408 Grant for State Fiscal Year 2010, for the Executive-Department of Public Safety-Justice Affairs Division, and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Corrections through the Community Corrections Act has awarded to the County of Summit grant funds for State Fiscal Year 2010, in the amount of \$757,199.00 for the 407 Grant and \$448,759.00 for the 408 Grant, for a total amount of \$1,205,958.00 for a community corrections program to be operated by the County Sheriff, the County Adult Probation Department and Oriana House, Inc.; and

WHEREAS, the County desires to enter into a contract with Oriana House, Inc. for the operation of a community corrections program for State Fiscal Year 2010, the period July 1, 2009 through June 30, 2010, in the amount of ~~\$813,357.00~~ \$813,361.00, which is funded by a portion of the grants; and

WHEREAS, this Council has determined after reviewing all pertinent information that is it necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned contract with Oriana House, Inc.;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a contract with Oriana House, Inc. for the operation of a community corrections program for State Fiscal Year 2010, the period July 1, 2009 through June 30, 2010, in the amount of ~~\$813,357.00~~ \$813,361.00, which is funded by a portion of the 407 and 408 Community Corrections Act Grants awarded to the County of Summit for State Fiscal Year 2010.

SECTION 3

This Resolution is declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately authorizing the Executive to execute a contract with Oriana House, Inc. for the operation of a community corrections program, which is funded by a portion of the 407 and 408 grants, and appropriating funds for such grant period.
