An amended Resolution ratifying the County Executive's execution of documents necessary to accept the award from the State of Ohio Department of Rehabilitation through the Community Corrections Act for State Fiscal Year 2010 of grant funds in the amount of \$757,199.00 for the 407 Grant and \$448,759.00 for the 408 Grant, for a total amount of \$1,205,958.00, with no local cash match requirement, for a community corrections program to be operated by the County Sheriff, the County Adult Probation Department and Oriana House, Inc., and appropriating said funds for the period of July 1, 2009 through December 31, 2009, for the Executive-Department of Public Safety-Justice Affairs Division and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Corrections through the Community Corrections Act ("CCA") has renewed the award to the County of Summit of a CCA grant for State Fiscal Year 2010 in the amount of \$757,199.00 for the 407 Grant and \$448,759.00 for the 408 Grant, for a total amount of \$1,205,958.00 for a community corrections program to be operated by the County Sheriff, the County Adult Probation Department and Oriana House, Inc. from July 1, 2009 through June 30, 2010; and

WHEREAS, the County Executive executed the documents necessary to accept the aforementioned grant awards; and

WHEREAS, it is necessary for County Council to ratify the Executive's execution of the grant documents; and

WHEREAS after reviewing all pertinent information, this Council has determined that it is necessary and in the best interest of the County to appropriate the CCA 407 and 408 Grant funds in the amount of \$1,205,958.00 for the grant period;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 4




SECTION 5
