A Resolution increasing appropriations in the Sheriff's Concealed Weapon Administration Fund in the amount of \$55,000.00, and the Sheriff's Foreclosure Rotary Fund in the amount of \$165,000.00, for a total of \$220,000.00, to meet projected expenditures for the balance of 2009, for the Sheriff, and declaring an emergency.

WHEREAS, there is a need for additional appropriations in the amount of \$55,000.00 in the Sheriff's Concealed Weapon Administration Fund and \$165,000.00 in the Sheriff's Foreclosure Rotary Fund in order to move personnel costs from the General Fund for 2009; and

WHEREAS, this Council has determined by reviewing all pertinent information that the increase in appropriations in the amount of \$55,000.00 in the Sheriff's Concealed Weapon Administration Fund and \$165,000.00 in the Sheriff's Foreclosure Rotary Fund for a total of \$220,000.00, is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Appropriations are hereby increased as follows:


SECTION 5
