A Resolution pursuant to Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary Hiring Freeze," to authorize the Clerk of Courts to externally post for and hire an individual into the position of temporary non-bargaining classified Clerk 1 to represent the Clerk of Courts as his designee at the County of Summit Board of Revision, at a cost of \$12.06/hr. at up to 40 hrs per week, and to keep that temporary position filled through December 2009, for a total not to exceed cost of \$13,000.00, for the Clerk of Courts, and declaring an emergency.

WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary Hiring Freeze," to control and potentially reduce, the County's budget deficit; and

WHEREAS, Section 164(j) provides that if a County office is able to demonstrate that the filling of an existing position by hiring a new employee is necessary for the effective and continued operation of the office, Council may adopt a Resolution authorizing the office to hire a new employee; and

WHEREAS, the County has created a second Board of Revision to hear the large numbers of appeals of property valuations; and

WHEREAS, the Clerk of Courts has determined that in order to fill his slot on the second Board of Revision, it is necessary for the effective and continued operation of his office to externally post for and hire an individual into the position of temporary non-bargaining classified Clerk 1 to represent the Clerk of Courts as his designee at the County of Summit Board of Revision, at a cost of \$12.06/hr. at up to 40 hrs per week, and to keep that temporary position filled through December 2009, for a total not to exceed cost of \$13,000.00;

WHEREAS, the Clerk of Courts requests that this Council adopt a Resolution pursuant to Section 169.04(j) authorizing him to post for and hire a person into the aforementioned position; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Clerk of Courts pursuant to Section 169.04(j) to post for and hire said position.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

County Council hereby determines that Clerk of Courts has demonstrated that it is necessary for the effective and continued operation of the Clerk of Courts Office to authorize the Clerk of Courts pursuant to Section 169.04(j) of the Codified Ordinances to externally post for and hire an individual into the position of temporary non-bargaining classified Clerk 1 to represent the Clerk of Courts as his designee at the County of Summit Board of Revision, at a cost of \$12.06/hr. at up to 40 hrs per week, and to keep that temporary position filled through December 2009, for a total not to exceed cost of \$13,000.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason to immediately authorize the Clerk of Courts to post for and hire a person into said position so that the Board of Revision may continue to function effectively.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
