**A Resolution appropriating \$310,855.00 in Workforce Investment Act ("WIA") grant funds received as a result of the American Recovery and Reinvestment Act ("ARRA") of 2009 which includes \$193,405.00 for the Youth Employment for Success ("YES") Summer Program through 9/30/2009, as well as \$117,450.00 for the first half of the YES Year-Round Program, for the Executive, and declaring an emergency.**

WHEREAS, the ARRA of 2009 was signed into law by President Obama on 2/27/2009; and

WHEREAS, ARRA grant funds in the amount of \$310,855.00 were made available and accepted in Resolution 2009-213 for stimulus projects within the County of Summit for State Fiscal Year 2009 WIA grant funds, for educational and employment services, for both Youth Summer and Youth Year-round programs; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
