A Resolution appropriating \$400,000.00 in State Fiscal Year 2010 Temporary Assistance to Needy Families ("TANF") funds for the period 7/1/09 through 6/30/10 awarded by the County Executive's Department of Job and Family Services to the County of Summit Juvenile Court, for the expenditures for the period 7/1/09 through 12/31/09, for the Juvenile Court, and declaring an emergency.

WHEREAS, the County Executive's Department of Job and Family Services has awarded TANF funds, in an amount not to exceed \$400,000.00, to the County of Summit Juvenile Court for the period 7/1/09 through 6/30/10; and

WHEREAS, this award was approved in legislation 2009-207 and will support the Juvenile Court's Family Resource Center which delivers intensive case management to at-risk youth and their families, as well as serving as a resource for other court-involved youth and the community as a whole; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
