A Resolution authorizing the County Executive to execute any documents necessary to accept a State Fiscal Year 2010 RECLAIM Ohio grant in the amount of \$3,548,472.43, with no local cash match requirement, from the Ohio Department of Youth Services, for the period 7/01/09 through 6/30/10 and appropriating \$1,572,000.00 for expenditures for the period 7/1/09 through 12/31/09, for the County of Summit Juvenile Court, and declaring an emergency.

WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's overburdened juvenile justice system and allows local courts to target specific areas to help divert youth from being institutionalized; and

WHEREAS, the County of Summit Juvenile Court has been awarded a State Fiscal Year 2010 RECLAIM Ohio grant from the Ohio Department of Youth Services which has estimated the annual award at \$3,548,472.43, with no local cash requirement, for the period 7/1/09 through 6/30/10; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any document necessary to accept the award of the aforementioned grant from the Ohio Department of Youth Services, and to appropriate the grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the State Fiscal Year 2010 RECLAIM award from the Ohio Department of Youth Services in the estimated amount of \$3,548,472.43, with no local cash match requirement.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 6

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Ohio Revised Code.
