WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's overburdened juvenile justice system and allows local courts to target specific areas to help divert youth from being institutionalized; and

WHEREAS, the County of Summit Juvenile Court has been awarded a State Fiscal Year 2010 RECLAIM Ohio grant from the Ohio Department of Youth Services which has estimated the annual award at \$3,548,472.43, with no local cash requirement, for the period 7/1/09 through 6/30/10; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any document necessary to accept the award of the aforementioned grant from the Ohio Department of Youth Services, and to appropriate the grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1
