A Resolution authorizing the County Executive to execute an Ohio Public Works grant application and associated documents, with Medina County as co-applicant, for the replacement of the Medina Line Road Bridge over a branch of Yellow Creek, located on the boundary of Bath Township in Summit County and Granger Township in Medina County, Council District 1, at a cost to the County not to exceed \$50,760.00, for the County Engineer, and declaring an emergency.

WHEREAS, the Engineer concludes that there is a public need to replace the Medina Line Road Bridge over a branch of Yellow Creek (Bridge No. BAT 002 1143, SFN 7732007), located on the boundary of Bath Township in Summit County and Granger Township in Medina County; and

WHEREAS, the County of Summit is eligible, with Medina County as co-applicant, to acquire State Issue 1 Local Transportation Improvement Program (LTIP) grant funds for the purpose of replacing said bridge; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County to apply for said funds, to authorize the expenditure of \$50,760.00 in County local matching road and bridge funds for said bridge replacement and to authorize the County Executive to execute a grant application and associated documents for the aforementioned replacement project;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is authorized to execute an Ohio Public Works grant application and associated documents, with Medina County as co-applicant, for State Issue 1 LTIP funds, for the purpose of replacing the Medina Line Road Bridge over a branch of Yellow Creek (Bridge No. BAT 002 1143), located on the boundary of Bath Township in Summit County and Granger Township in Medina County, Council District 1.

SECTION 2

The terms of said application shall allocate the cost of said replacement among the following participants, with the County of Summit's share (Item A) not to exceed \$50,760.00, and with other participants' shares (Items B and C) covering the remainder of the \$338,400.00 estimated project cost in amounts approximately equal to the following:

SECTION 3

The expenditure of \$50,760.00 in County local matching road and bridge funds as the County of Summit's share of the cost of the project is hereby authorized.

SECTION 4

The Clerk of Council is instructed to provide two certified copies of this Resolution to the County Engineer, for submission to the Ohio Public Works Commission with said funding application.

SECTION 5

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it will immediately allow the County to obtain grant funds for a needed bridge replacement.

SECTION 6

Provided this Resolution receives the affirmative vote of eight (8) members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 7

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
