WHEREAS, petitions have been filed to recall City of Akron Mayor Don Plusquellic, and a recall election has been scheduled for June 23, 2009; and

WHEREAS, during his 23 years as Mayor, Don Plusquellic has worked to make the City of Akron a state and national leader in economic development, job creation and job retention; and

WHEREAS, as Mayor, Don Plusquellic was instrumental in orchestrating the retention of The Goodyear Tire and Rubber Co. and Bridgestone-Firestone in the City of Akron and County of Summit, and the thousands of jobs working for each; and

WHEREAS, through Mayor Plusquellic's vision, Akron has been successful in attracting new business from overseas and across our nation and has begun such successful initiatives as the Akron Global Business Accelerator; and

WHEREAS, under Mayor Plusquellic, Akron is becoming a national leader in biomedical research and development and has begun the development of the Biomedical Corridor surrounding downtown Akron; and

SECTION 1
