A Resolution authorizing the County Executive to execute any documents necessary to accept an addendum to the Community-Based Correctional Facility ("CBCF") Subsidy Grant from the State of Ohio Department of Rehabilitation and Correction, for State Fiscal Year 2009 (7/1/08 through 6/30/09), increasing the amount of the grant by \$13,000.00, with no local cash match requirement, appropriating these additional funds for expenditures through 6/30/09, and authorizing the Executive to execute an amendment to the contract with Oriana House, Inc. for the operation of a CBCF from 7/1/08 through 6/30/09 to reflect the increase in grant funds, for the Executive, and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Correction has provided supplemental Community Based Correctional Facility ("CBCF") Subsidy Grant funds, in the amount of \$13,000.00, with no local cash match requirement, to the County of Summit for State Fiscal Year 2009 (7/1/08 through 6/30/09); and

WHEREAS, pursuant to Resolution No. 2008-286, the County Executive executed a contract with Oriana House, Inc. for the operation of a Community Based Correctional Facility from 7/1/08 through 6/30/09; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the addendum increasing the State Fiscal Year 2009 CBCF Subsidy Grant award, to appropriate grant funds and to authorize the Executive to execute an amendment to the contract with Oriana House, Inc. for the operation of a CBCF from 7/1/08 through 6/30/09 to reflect the increase in grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1
