A Resolution authorizing the County Executive to execute contracts, subject to the approval of the Board of Control, with the providers listed in Exhibit A, for State Fiscal Year 2009 Workforce Investment Act ("WIA") for educational and employment services for youth summer programs, for the period 5/1/09 through 9/30/09, and a year-round program for the period 7/1/09 to 6/30/10, in a total amount not to exceed \$1,005,980.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, the American Recovery and Reinvestment Act of 2009 ("ARRA") provided Workforce Investment Act ("WIA") Area 20, being Summit and Medina Counties, with WIA federal stimulus allocations for allowable expenditures made between 2/17/09 and 6/30/10; and

WHEREAS, this Council previously adopted Resolution No. 2009-169, which authorized the County Executive to accept the award by the Ohio Department of Job and Family Services of \$4,914,541.00 in WIA stimulus allocations and appropriated said allocations; and

WHEREAS, this Council subsequently adopted Resolution No. 2009-191, which confirmed the award by the Board of Control of State Fiscal Year 2009 WIA educational and employment services contract change orders and amendments for summer employment services with various providers, for the period 7/1/08 through 9/30/09, in a total amount not to exceed \$1,324,391.00; and

WHEREAS, remaining ARRA WIA federal stimulus funds are available; and

WHEREAS, the County of Summit wishes to award additional contracts for WIA educational and employment services with the providers listed in Exhibit A, attached hereto and incorporated herein as if fully restated, and to authorize the County Executive to execute contracts, subject to the approval of the Board of Control, with said providers, for youth summer programs, for the period 5/1/09 through 9/30/09, and a year-round program for the period 7/1/09 to 6/30/10, in a total amount not to exceed \$1,005,980.00; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute contracts, subject to the approval of the Board of Control, with the providers listed in Exhibit A for the aforementioned reasons;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute contracts, subject to the approval of the Board of Control, with the providers listed in Exhibit A, attached hereto and incorporated herein as if fully restated, for Fiscal Year 2009 Workforce Investment Act ("WIA") educational and employment services programs, for the period 5/1/09 through 9/30/09, and a year-round program for the period 7/1/09 to 6/30/10, in a total amount not to exceed \$1,005,980.00.
