**A Resolution extending the Summit County Abandoned & Vacant Property Task Force by 6 months for the County Council and the Executive, and declaring an emergency.**

WHEREAS, the Summit County Abandoned & Vacant Property Task Force was established by Resolution 2008-417 on October 21, 2008, with the purpose of addressing the problem of vacant and abandoned properties in Summit County and exploring ways to contribute to the economic growth of the County and improving the health and safety of its citizens; and

WHEREAS, members of the Summit County Abandoned & Vacant Property Task Force met several times to propose, discuss and review numerous proposals for decreasing the number of vacant and abandoned properties in Summit County; and

WHEREAS, members of the Summit County Abandoned & Vacant Property Task Force, at its meeting held May 7, 2009, determined the need for and approved the extension of the Task Force for 6 months; and

WHEREAS, it is necessary and in the best interest of the County of Summit for this Council to approve the extension of the task force by 6 months.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Summit County Abandoned & Vacant Property Task Force is hereby authorized to continue deliberations for an additional period of 6 months, beginning the first day following the sixth meeting of the task force.

SECTION 2

This Resolution is declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately extending the task force for 6 months.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.


SECTION 4
