WHEREAS, the County of Summit wishes to advertise for bids for the aforementioned project; and

WHEREAS, Council previously passed Resolution No. 2009-089 which authorized the funding for this project; and

WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of Council; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the County Executive to advertise for bids for the aforementioned project is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to advertise for bids for the roof replacement project at the men's Community Based Correctional Facility, 264 East Crosier Street, Akron, Ohio, for an estimated cost of \$250,000.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further reason of immediately authorizing the advertisement for bids.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
