A Resolution appropriating funds in the amount of \$402,000.00 from the United States Department of Housing and Urban Development ("HUD") Home Investment Partnership ("HOME") funds, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, HOME funds from HUD are available exclusively for the development and/or retention of affordable housing and at least 15% of the HOME allocations must be used for activities undertaken by Community Development Housing Organizations ("CHDO"); and

WHEREAS, the County of Summit has received acceptable proposals from Nazareth Housing Development Corporation and Neighborhood Development Services both of which are CHDO's, as well as a proposal from Habitat for Humanity of Summit County, a non-profit organization; and

WHEREAS, it is necessary to appropriate HOME funds in the amount of \$402,000.00 in order to fund said CHDO's; and

WHEREAS, this Council has determined by reviewing all pertinent information that the appropriation of the aforementioned HOME funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The HOME funds are hereby appropriated as follows:

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately provide for the necessary HOME funds appropriations for the County Executive's Department of Community and Economic Development.
