A Resolution increasing the petty cash fund for the Clerk of Courts' Title & Passport Division, from \$2,000.00 to \$5,000.00, to be used by the three Title offices and BMV Satellite Offices and declaring an emergency.

WHEREAS, the Clerk of Courts Title & Passport Division currently divides \$2,000.00 in its petty cash fund between the three Title Bureau offices located in Akron, Northfield, and Portage Lakes; and

WHEREAS, the amount of \$2,000.00 is insufficient for carrying out the functions of the Title & Passport Division; and

WHEREAS, the Clerk of Courts wishes to increase the amount to \$5,000.00; and

WHEREAS, County Council previously adopted Resolution No. 2007-114, which increased the amount of the petty cash fund for the Title & Passport Division from \$675.00 to \$2,000.00; and

WHEREAS, this Council has determined by reviewing all pertinent information that increasing the petty cash fund for the Clerk of Courts' Title & Passport Division, from \$2,000.00 to \$5,000.00, to be used by the Title offices and BMV Satellite offices is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit. State of Ohio, that:

SECTION 1

The petty cash fund for use by the Clerk of Courts' Title & Passport Division for its operations in the three Title Offices and BMV Satellite offices located in the County of Summit is hereby increased from \$2,000.00 to \$5,000.00. The increase in the petty cash fund shall be processed in accordance with the Codified Ordinances of the County of Summit and the Ohio Revised Code.

SECTION 2

Title & Passport Division shall remain fixed at \$5,000.00 unless modified by further action of this Council.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that is it necessary to immediately increase the petty cash fund of the Clerk of Courts' Title & Passport Division from \$2,000.00 to \$5,000.00.
