A Resolution appropriating additional grant funds for Oriana House, Inc., from the State of Ohio Department of Rehabilitation through the Community Corrections Act for State Fiscal Year ending June 30, 2009, in the amount of \$8,150.00 for the 407 Grant and \$14,930.00 for the 408 Grant, for a total amount of \$23,080.00, with no local cash match requirement, for Oriana House, Inc., staff training, for the Executive-Department of Public Safety-Justice Affairs Division and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Corrections through the Community Corrections Act has awarded Oriana House, Inc., through the County of Summit, additional grant funds for State Fiscal Year 2009 in the amount of \$8,150.00 for the 407 Grant and \$14,930.00 for the 408 Grant, for a total amount of \$23,080.00 for Oriana House, Inc., staff training, with no local cash match requirement; and

WHEREAS, this Council has determined by reviewing all pertinent information, that is it necessary and in the best interest of the County to appropriate the additional 407 and 408 Community Corrections Act funds in the amount of \$23,080.00 for the grant period;


SECTION 5
