A Resolution authorizing the County Executive to advertise for bids for the County road construction project, bridge engineering and construction projects and pavement, culvert, and ditch maintenance projects, for an estimated total cost not to exceed \$1,600,400.00, for the County Engineer's 2009 Capital Improvement Program, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously approved Resolution No. 2009-048, which approved and appropriated funds in the amount of \$4,973,200.00 for the balance of projects in the County's 2009 Capital Improvement Program, including projects and funds for the County Engineer's 2009 Capital Improvement Program; and

WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires this Council's authorization for the County Executive to advertise for bids for projects that are included in the Engineer's 2009 Capital Improvement Program; and

WHEREAS, a list of the Engineer's proposed projects is attached hereto as Exhibit "A" and incorporated herein as if fully restated; and

WHEREAS, this Council has determined by reviewing all pertinent information that is necessary and in the best interest of the County of Summit to authorize the Executive to advertise for bids for the proposed projects listed in Exhibit "A;"

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is authorized to advertise for bids for the projects listed in Exhibit "A" and incorporated herein as if fully restated, for an estimated total cost not to exceed \$1,600,400.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason that it authorizes the Executive to advertise for projects proposed by the Engineer that are included in his 2009 Capital Improvement Program.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
