An amended Resolution adjusting \$22,340.00 ~~\$10,240.00~~ in appropriations for the Youth Employment for Success ("YES") Program, for the period 1/1/09 through 6/30/09, from the Department of Job and Family Services State Fiscal Year 2009 Temporary Assistance to Needy Families ("TANF") grant, with no local cash match requirement, for the Executive's Department of Communications, and declaring an emergency.

WHEREAS, the YES program provides job readiness training, paid work experience, mentoring and guidance services for school youths ages 14 -18; and

WHEREAS, Resolution No. 2008-257, which awarded a professional service contract not to exceed \$242,250.00 in TANF funds, for the period 7/1/2008 through 6/30/2009, for the County Executive's Department of Communications to provide the YES program; and

WHEREAS, Resolution No. 2008-534 appropriated the YES Program carry-over funding from the Executive's Department of Job and Family Services with no local cash match requirement, for the period 1/1/09 through 6/30/09; and

WHEREAS, adjustments to these appropriations are required for operations in the second half of the YES grant program year, for the period 1/1/2009 through 6/30/2009; and

WHEREAS, this Council has determined by reviewing all pertinent information that the adjustments in the appropriation of the aforementioned grant funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Appropriation of TANF funds for the YES Program are hereby adjusted as follows:
