An Ordinance amending Section 197.04 of the Codified Ordinances of the County of Summit, entitled "Change Fund for Environmental Services", for the purpose of increasing the Permanent Change Fund for use by the Department of Environmental Services from \$150.00 to \$300.00, for the Executive's Department of Environmental Services ("DOES"), and declaring an emergency.

WHEREAS, DOES collects various fees and charges in its daily business prescribed by Ohio R.C. 6117.01 et seq., and makes various petty cash purchases needed by DOES; and

WHEREAS, Section 197.04 of the Codified Ordinances of the County of Summit states that the Permanent Change Fund for DOES shall remain fixed at \$150.00 unless modified by further action of Council; and

WHEREAS, the \$150.00 Permanent Change Fund is insufficient for the business of DOES, thereby requiring an increase in the Permanent Change Fund to \$300.00;

WHEREAS, this Council has determined by reviewing all pertinent information that increasing the Permanent Change Fund for DOES from \$150.00 to \$300.00 is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of Ohio, that:

#### SECTION 1

Section 197.04 of the Codified Ordinances of the County of Summit, entitled "Change Fund for Environmental Services", is hereby amended as follows:

#### **197.04 CHANGE FUND FOR ENVIRONMENTAL SERVICES.**

(a) There is hereby created a Permanent Change Fund for use by the Department of Environmental Services, as described in subsections (b) and (c) hereof, for use in conducting the necessary daily business and duties prescribed by Ohio R.C. ~~317.04~~ 6117.01 et seq. and making various petty cash purchases needed by the Department.

(b) The Department shall issue a purchase order for ~~one hundred fifty dollars (\$150.00)~~ three hundred dollars (\$300.00) which shall be encumbered from the Sewer and Water Funds Account Nos. 6010-150-4503 and 6002-150-4503, respectfully. The Department shall issue a warrant payable to the order of the Budget and Management Director. Such Director shall endorse and cash the warrant and deposit such money into the cash box to be used at the Department.

c) The Permanent Change Fund shall remain fixed at ~~one hundred fifty dollars (\$150.00)~~ three hundred dollars (\$300.00) unless modified by further action of Council.

SECTION 2

This Ordinance is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason that it is necessary to immediately increase the Permanent Change Fund for DOES from \$150.00 to \$300.00.

SECTION 3

Provided this Ordinance receives the affirmative vote of 8 members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
