A Resolution confirming an award by the Board of Control of Change Order #1 with Goodwill Industries of Akron, Ohio, Inc., for additional WIA Job Center employment services for the period 7/1/08 to 6/30/09, in an amount not to exceed \$93,000.00 (for an increase of 10%), for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2008-220 for the 2009 Agreement with Goodwill Industries of Akron, Ohio, Inc., in the amount of \$949,998.88; and

WHEREAS, the Board of Control, at its meeting held February 25, 2009, awarded Change Order #1 with Goodwill Industries of Akron, Ohio, Inc., for additional WIA Job Center employment services for the period 7/1/08 to 6/30/09, in an amount not to exceed \$93,000.00 (for an increase of 10%); and

WHEREAS, County Council has determined by reviewing all pertinent information that Change Order #1 is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of Change Order #1 with Goodwill Industries of Akron, Ohio, Inc., for additional WIA Job Center employment services for the period 7/1/08 to 6/30/09, in an amount not to exceed \$93,000.00 (for an increase of 10%), is hereby confirmed and the County Executive is hereby authorized to executive such change order.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately providing the additional WIA Job Center employment services.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.


SECTION 4
