A Resolution authorizing the appropriation of the Workforce Investment Act ("WIA") Incumbent Worker Training Program allocation in the amount of \$668,330.00 for the period January 1, 2009 through December 31, 2009, wherein the County of Summit Department of Job and Family Services serves as the fiscal agent, and further authorizing the County Executive to execute agreements between the County of Summit and the State of Ohio selected employers for the receipt of the Incumbent Worker Training funds, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, pursuant to Substitute House Bill 372, the State of Ohio implemented an Incumbent Worker Training ("IWT") program, financed by federal Workforce Investment Act ("WIA") funds, to be administered through a joint partnership between the Ohio Department of Job and Family Services, the Ohio Department of Development and the local workforce investment areas; and

WHEREAS, Summit County falls under the purview of WIA Local 20, along with Medina County, with the County of Summit Department of Job and Family Services acting as the fiscal agent for WIA Local Area 20; and

WHEREAS, pursuant to the WIA Incumbent Worker Training program, the State of Ohio has selected certain employers in both Summit and Medina County to receive the WIA Incumbent Worker Training funds, which will pass through the County of Summit Department of Job and Family Services as the WIA Local 20 fiscal agent; and

WHEREAS, the WIA Incumbent Worker Training funds are distributed to the State of Ohio selected employers by the County of Summit Department of Job and Family Services pursuant to a standard State-developed agreement that must be executed by the County Executive for employers located in Summit County and the Medina County Commissioners for employers located in Medina County; and

WHEREAS, pursuant to Resolution Nos. 2008-365 and 2008-511, this Council authorized the Executive to execute several WIA Incumbent Worker Training agreements and appropriated WIA Incumbent Worker Training funds received by the County; and

WHEREAS, the County of Summit Department of Job and Family Services has received notification from the State of Ohio of an award of an additional \$668,330.00, to be allocated among eight new State of Ohio selected companies, said companies being set forth on the allocation letter attached hereto as Exhibit A; and

WHEREAS, pursuant to Section 177.21(2)(b) of the Codified Ordinances of the County of Summit, any contract with a vendor exceeding \$25,000.00 in the aggregate in any calendar year which is funded by state or federal pass through dollars, must be approved by this Council; and

WHEREAS, the County of Summit Department of Job and Family Services anticipates that the amount of pass-through WIA Incumbent Worker Training funds that will be paid pursuant to the State-developed agreement may exceed the \$25,000.00 threshold established by Section 177.21(2)(b) for seven of the eight State of Ohio selected companies in calendar year 2009; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate said WIA Incumbent Worker Training funds and to authorize the County Executive to execute said WIA Incumbent Worker Training pass-through agreements that may exceed an aggregate of \$25,000.00 in calendar year 2009.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Funds are hereby appropriated as follows for the period January 1, 2009 through December 31, 2009:
