WHEREAS, the Summit County Law Library functions under a county law library association board of trustees as a private non-profit entity with County of Summit support formerly set forth in Section 3375.49 of the Ohio Revised Code, including reimbursement of a portion of the cost of compensation for the law library director and assistant directors; and

WHEREAS, Substitute House Bill (HB) 420, which passed in December 2008, effectively repealed Section 3375.49, making the County responsible for reimbursing the full cost of compensation for the law library director and assistant directors in 2009; and

WHEREAS, this Council has found and determined, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to appropriate funds in the amount of \$131,600.00 for the cost of compensation for the law library director and assistant directors for the aforementioned reasons; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
