A Resolution appropriating carryover funds of \$614,163.27, with no local cash match requirement, in Public Safety-Emergency Management Agency Grants including Federal Homeland Security and Justice funds for 1/1/09 through 12/31/09, for the Executive's Department of Law, Division of Public Safety- Emergency Management Agency, and declaring an emergency.

WHEREAS, Resolution No. 2008-010 accepted pass-through Homeland Security funds for a Metropolitan Medical Response System (MMRS) grant for 7/1/07 through 3/31/10 for training to enhance the capabilities of first responders and receivers to emergency situations; and,

WHEREAS, Resolution No. 2008-011 approved the acceptance of pass-through Homeland Security funds for a State Homeland Security Program (SHSP) grant for 7/1/07 through 3/31/10 to better mitigate, prepare, respond and recover from an act of terrorism and other disasters; and

WHEREAS, Resolution No. 2008-029 approved the acceptance of a U.S. Department of Justice award for a State Criminal Alien Assistance Program grant which is a formula award with full carryover allowance which primarily assists the jail system with trainings and other support services; and

WHEREAS, Resolution No. 2008-058 approved the acceptance of pass-through Homeland Security funds for a 2007 State Regional Hazmat grant to provide equipment to support Hazardous Materials Response Teams; and

WHEREAS, Resolution No. 2008-360 approved the acceptance of funds from the State of Ohio Department of Health, for a Public Health Infrastructure (PHI) grant for 8/10/08 through 8/9/09 to coordinate mitigation, preparedness, response and recovery efforts within a designated 13 Ohio County Homeland Regions; and

WHEREAS, Resolution No. 2008-432 approved the acceptance of a Byrne Justice pass-through grant from the City of Akron (JAG) for the purchase of three (3) 800MHz Radios for the County Sheriff's Office; and

WHEREAS, it is necessary to appropriate the available balance of these grant funds; and

WHEREAS, this Council has determined by reviewing all pertinent information that the appropriation of the aforementioned grant funds is necessary and in the best interest of the County of Summit;
