A Resolution adjusting existing appropriations by \$1,248,000.00 within Public Assistance Workforce Development fund for the period 1/01/09 through 12/31/09, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, Amended Resolution No. 2008-485 appropriated funds within the 2009 Operating Budget; and

WHEREAS, \$1,248,000.00 in original appropriations in the Public Assistance Workforce Development fund require an adjustment between accounts in order to provide services; and

WHEREAS, this Council has determined by reviewing all pertinent information that the adjustment of appropriations in the aforementioned public assistance fund is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Appropriations are hereby adjusted as follows:

The County Fiscal Officer is hereby authorized and directed to effect the within appropriations adjustment.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that the adjustment to the appropriation is needed for the Workforce Development fund's public assistance payments.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
