A Resolution appropriating funds as required by Ohio Revised Code (ORC) §3113.35, for the Domestic Violence Trust Fund, in the amount of \$186,000.00 which includes \$60,804.13 paid into the fund the for the period 7/1/08 through 12/31/08 and the balance being for the fund's receipts projected for the period 1/1/09 through 12/31/09 for the Battered Women's Shelter, for the Executive, and declaring an emergency.

WHEREAS, funds in the amount of \$60,804.13 were paid into the Domestic Violence Fund as required by ORC §3113.35 during the period July 1, 2008 through December 31, 2008 and these funds are to be paid in a timely manner to the Battered Women's Shelter; and

WHEREAS, The Battered Women's Shelter has submitted the necessary application for the calendar year 2009 funds in accordance with the provisions in ORC §3113.35 and is eligible for the specified funds collected in 2009; and

WHEREAS, funds collected for the Domestic Violence Fund under ORC §3113.35 in the period 1/1/09 through 6/30/09 are to be paid out by 7/15/09; and

WHEREAS, funds collected for the Domestic Violence Fund under ORC §3113.35 in the period 7/1/09 through 12/31/09 are to be paid out by 1/15/10; and

WHEREAS, this Council has determined by reviewing all pertinent information that the appropriations of the aforementioned funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:


