WHEREAS, the County of Summit meets the Ohio Department of Public Safety, OCJS, and the U.S. Department of Justice, Bureau of Justice Assistance, funding requirements for a county-wide Drug Unit task force; and

WHEREAS, the Sheriff's Office has been awarded Justice Assistance Grant (JAG) funds of \$80,400.00 with a 25% cash match requirement of \$26,800.00, which will be paid by Summit County Drug Unit Project Income checking account, for a project total of \$107,200.00, to fund a county-wide Drug Unit task force which will specifically target the manufacture, distribution and acquisition of illegal drugs in the County of Summit; and

WHEREAS, this Council has determined by reviewing all pertinent information that authorizing the County Executive to execute any documents necessary to accept the aforementioned grant, and the appropriations of the aforementioned grant funds is necessary and in the best interest of the County of Summit;
