WHEREAS, the Court of Common Pleas-General Division utilizes proprietary case management software purchased from Sadler-NeCamp Financial Services, Inc. dba Proware; and

WHEREAS, because said software is proprietary, Sadler-NeCamp Financial Services, Inc. dba Proware, is a Sole Source provider for case management system software support and maintenance services; and

WHEREAS, the Board of Control, at its April 22, 2020 meeting, awarded a professional service contract with Sadler-NeCamp Financial Services, Inc. dba Proware, as a Sole Source, subject to the approval of the IT Board, for case management system software support and maintenance services, for a one-year term, from 1/1/20 through 12/31/20, for a one-year term, from 1/1/20 through 12/31/20, for an amount not to exceed \$191,440.00 for the first year, with four options to renew for an additional one-year term, for a total cost not to exceed \$999,540.00 for the five-year period, subject to confirmation by County Council; and

WHEREAS, the cost of said software over the five-year period will be \$191,440.00 for Year 1; \$195,815.00 for Year 2; \$200,280.00 for Year 3; \$204,075.00 for Year 4 and \$207,930.00 for Year 5, for a total amount not to exceed \$999,540.00 for the five-year period; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned professional service contract with Sadler-NeCamp Financial Services, Inc. dba Proware is necessary and in the best interest of the County of Summit;
