7 **A Resolution accepting the dedication of Sunset Drive as a public road, pursuant to Section**
8 **5553.31 of the Ohio Revised Code, located in Copley Township, in Council District 5, for**
9 **the Executive, and declaring an emergency.**

11 WHEREAS, Sunset Drive situated in the County of Summit, Copley Township, in
12 Council District 5, is a private road; and

13
14 WHEREAS, the Copley Township Board of Trustees desire to construct a new Police and
15 Fire Facility on Sunset Drive; and

16
17 WHEREAS, the Copley Township Board of Trustees desire to dedicate Sunset Drive as a
18 public road; and

19
20 WHEREAS, all property owners abutting the road have agreed to dedicate Sunset Drive
21 as a public road; and

22
23 WHEREAS, there are no liens under Section 505.82 of the Ohio Revised Code attached
24 to any of the properties involved in this dedication; and

25
26 WHEREAS, the County Engineer has prepared a plat for the purposes of dedicating
27 Sunset Drive; and

29 WHEREAS, the Copley Township Board of Trustees have petitioned Summit County
30 Council to accept the dedication of Sunset Drive pursuant to their Resolution 2020-52; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that the acceptance of the dedication of Sunset Drive is necessary and in the best interest of the
34 County of Summit;

36 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

39 SECTION 1

41 This Council hereby accepts the dedication of Sunset Drive as a public road pursuant to
42 Section 5553.31 of the Ohio Revised Code, said road being a township road for maintenance
43 purposes, as set forth in the plat attached hereto and marked as Exhibit "A".

45 SECTION 2

47 The plat of dedication shall be signed on behalf of the County Council and the Summit
48 County Executive, and the Clerk of Council shall transmit the executed plat, with a copy of this
49 Resolution, to the Summit County Fiscal Office, Recording Division for recording and to the
50 Summit County Engineer for inclusion in the County's permanent road records.

7 This Resolution is hereby declared an emergency in the interest of the health, safety and
8 residents of the County of Summit and for the further purpose of immediately accepting the
9 dedication of Sunset Drive as a public road.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and of any of its committees that resulted in such formal action,

23 121.22 of the Ohio Revised Code.
