7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**  
8 **professional service contract with GPD Group, Inc. for design services and construction**  
9 **administration for the Q-614 DSSS Operations Facility Project, located in the City of**  
10 **Akron, in Council District 5, in an amount not to exceed \$24,544.49, (for a cumulative**  
11 **increase of 3.67%), for a total amount not to exceed \$693,919.49, for the Executive's**  
12 **Department of Sanitary Sewer Services, and declaring an emergency.**

13  
14 WHEREAS, County Council previously adopted Resolution No. 2018-526, which  
15 authorized the County Executive to execute, subject to the approval of the Board of Control, a  
16 professional service contract with GPD Group, Inc., for design services and construction  
17 administration for the Q-614 DSSS Operations Facility Project (the "Project"), located in the  
18 City of Akron, in Council District 5, in an amount not to exceed \$669,375.00; and

19  
20 WHEREAS, additional design services are necessary for the Project to cover out of scope  
21 efforts, including relocation of underground structures, further investigation and testing of soils,  
22 additional geo-technical work and surveying and a re-plat of the parcel, resulting in the  
23 aforementioned cost increase; and

25 WHEREAS, the Board of Control, at its meeting held April 22, 2020, awarded Change  
26 Order No. 1 to the professional service contract with GPD Group, Inc. for the Project, in an  
27 amount not to exceed \$24,544.49, (for a cumulative increase of 3.67%), for a total amount not to  
28 exceed \$693,919.49; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that Change Order No. 1 to the aforementioned professional service contract with GPD Group,  
32 Inc. is necessary and in the best interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

39 The award by the Board of Control of Change Order No. 1 to a professional service  
40 contract with GPD Group, Inc. for design services and construction administration for the Q-614  
41 DSSS Operations Facility Project (the "Project"), located in the City of Akron, in Council  
42 District 5, in an amount not to exceed \$24,544.49, (for a cumulative increase of 3.67%), for a  
43 total amount not to exceed \$693,919.49, is hereby confirmed and the County Executive is hereby  
44 authorized to execute such change order and any other necessary related documents.

48 This Resolution is declared an emergency in the interest of the health, safety and welfare  
49 of the residents of the County of Summit and for the further reason to immediately confirm the  
50 award of a necessary change order to the professional service contract in order to cover the  
51 increased cost of design services essential to maintaining the Project's completion timeline.

16 121.22 of the Ohio Revised Code.


