7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **American Roadway Logistics, Inc., for the 2020 Summit County Regional Pavement**
9 **Marking Program, in an amount not to exceed \$234,962.80, for the Engineer, and declaring**
10 **an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized
13 the County Executive to advertise as needed for bridge engineering and construction projects,
14 and pavement maintenance projects, for the Engineer's 2020 Capital Improvements Program, for
15 an estimated total cost not to exceed \$5,290,750.00; and

17 WHEREAS, following the receipt and review of bids, the County Executive proposes
18 entering into a construction contract with American Roadway Logistics, Inc. for the 2020
19 Summit County Regional Pavement Marking Program, in an amount not to exceed \$234,962.80;

22 WHEREAS, the Board of Control, at its meeting held April 22, 2020, awarded a
23 construction contract with American Roadway Logistics, Inc. for the 2020 Summit County
24 Regional Pavement Marking Program, in an amount not to exceed \$234,962.80, subject to
25 confirmation by County Council; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that aforementioned construction contract with American Roadway Logistics, Inc. is necessary
29 and in the best interest of the County of Summit.;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that;

36 The award by the Board of Control of a construction contract with American Roadway
37 Logistics, Inc., for the 2020 Summit County Regional Pavement Marking Program, in an amount
38 not to exceed \$234,962.80, is hereby confirmed and the County Executive is hereby authorized
39 to execute such construction contract and any other necessary related documents.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further purpose to immediately
45 provide a necessary construction contract for the 2020 Summit County Regional Pavement
46 Marking Program.
