7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Ronyak Paving, Inc. for the 2020 Summit County 422 Resurfacing Program, in an amount**
9 **not to exceed \$1,084,857.05, for the Engineer, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized
12 the County Executive to advertise as needed for bridge engineering and construction projects,
13 and pavement maintenance projects, for the Engineer's 2020 Capital Improvements Program,
14 for an estimated total cost not to exceed \$5,290,750.00; and

16 WHEREAS, following the receipt and review of bids, the County Executive proposes
17 entering into a construction contract with Ronyak Paving, Inc. for the 2020 Summit County 422
18 Resurfacing Program, in an amount not to exceed \$1,084,857.05; and

20 WHEREAS, the Board of Control, at its meeting held on April 8, 2020, awarded a
21 construction contract with Ronyak Paving, Inc. for the 2020 Summit County 422 Resurfacing
22 Program, in an amount not to exceed \$1,084,857.05, subject to confirmation by County Council;

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned construction contract with Ronyak Paving, Inc. is necessary and in the
27 best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The award by the Board of Control of a construction contract with Ronyak Paving, Inc,
35 for the 2020 Summit County 422 Resurfacing Program, in an amount not to exceed
36 \$1,084,857.05, is hereby confirmed and the County Executive is hereby authorized to execute
37 such construction contract and any other necessary related documents.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further purpose to immediately
43 providing a necessary construction contract for the 2020 Summit County 422 Resurfacing
44 Program.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
